 - i) all prove of delivery documents signed by the consignee (including, but not limited such as CMR, delivery note, bill of lading, invoices, insurance policies regarding product delivery, documents issued by state authorities, bank documents etc.),
 - ii) filled written notice of receipt of products (delivery note) in case of delivery in EU territory or
 - Export Declaration documents discharged by the EU customs at the border of exit from the EU territory, as applicable. In case that after aforementioned period no prove of delivery documents, filled written notice of receipt of products or discharged Export Declarations, as applicable, have been received by AXIAL, we will indemnify and compensate to AXIAL all and any amounts of VAT and fines and penalties applicable for such products at the first request of AXIAL, including to pay contractual penalty to AXIAL in amount of 10% of the tax payments and fines applied by public authorities to AXIAL.
- 1.4. In case we fail to comply with any responsibilities herein contain, we hereby agree to indemnify and hold AXIAL harmless from and against any and all losses, costs, expenses or liabilities, including without limitation attorneys fees, that AXIAL may suffer or incur as a result of or in connection with our failure to follow the restrictions and obligations herein contained.
